BLUE LIFE KARATE CLASSIC 2024 TOURNAMENT RULES

GENERAL

- .Proper martial arts uniform required. Must be neat and clean.
- .Decision of the judges is final.
- .Ringside coaching is not permitted.
- .Only competitors and judges will remain in the ring.
- .Failure to abide by the rules will result in disqualification.

KATA – WEAPONS

- .There will be 3 to 5 judges in each ring. Competitors have a maximum potential of 40 points. The highest each judge can award is range from 9.0 to 10.0 points.
- .Kata must be performed in proper uniform, representative of the martial arts.
- .Kata will be judged by form, movement, impact potential and general technical performance.
- .Competitors must approach judges, bow, state name & kata, then move away from the judges and begin. Upon completion of the kata, the competitor will remain in the ring for scoring.
- .Dropping your weapon or making a mistake on your kata will mean disqualification.
- .In case of a mistake, the competitor will receive one chance to redo kata (under brown belt only).
- .In the event of a tie, competitors will have to compete in a tiebreaker. The competitor has the choice to present another kata or weapon. The winner will be determined by a show of hands. (NOTE: in the black belt level, the competitor must do a different kata or weapon.)

KUMITE – SPARRING

- .All competitors must wear foam safety gear for head, hands and feet. Mouthpiece is mandatory for all competitors. Groin protector is mandatory for all male competitors.
- .Disrespect for the judges will not be tolerated & will be cause for disqualification.
- .Competitors will bow to the judges, to each other, take a ready position and begin on the command.
- .First competitor to receive 3 points or 2 minutes is the winner.
- .Advanced & Black belt divisions will be 5 points or 2 minutes most accumulated points.
- .Only single points will be awarded, no half points.
- .There will be no contact to the face at any time. Light contact to Head Gear.
- .Competitors wearing face shield will understand that light contact to their shield will be considered a point.
- .There will be no techniques to the joints of the body (knees, elbows), groin, neck or spine.
- .All target areas are above the belt, in front of the body. Any part of the head, with the exception of the face, will be a target area (controlled touch to the head gear – no contact to the front of the face!). No blind techniques are permitted.
- .Drawing of blood due to a blow will result in immediate disqualification.
- .One warning on accidental contact. Second contact warning will result in disqualification. Warnings will be determined by at least 2 judges along with Center Judge.
- .Any Debates must be sent to the division Arbitrator. Arguing with judges (competitors or spectators) will result in competitor's disqualification.
- .All first place winners in Kumite & Kata Divisions will participate in the Grand Champion Competitions (junior or adult). Elimination round 5 points, Grand Championship 7 points.
